- 2. [continuation] Michael S. Dell is the controlling member of MSD Capital Management and may be deemed to beneficially own securities owned by MSD Capital Management. Each of Messrs. Dell, Fuhrman, Phelan and Lisker disclaims beneficial ownership of such securities except to the extent of any pecuniary interest therein. Multi-Strategy is owned and controlled in the same manner as Coral Rock, except for a small ownership difference among the limited partners of each fund.
